### NMSBA serves small businesses from every industry type in the state:

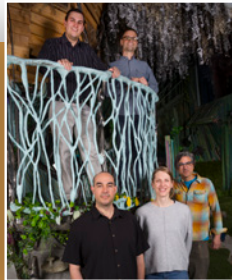

## Eligibility

- Are you a for-profit small business located in New Mexico?
- Do you pay or file gross receipts taxes to the State of New Mexico?

## If you answered yes to these questions, you can qualify for technical assistance in the form of research hours valued up to:

- \$20,000 annually if your small business is located in Bernalillo or Santa Fe counties
- \$40,000 annually if your small business is located outside of Bernalillo or Santa Fe counties

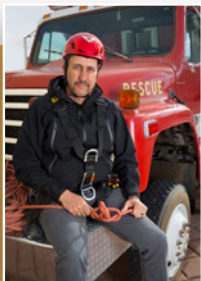
## Restrictions

- The assistance provided must not be available through private industry at a reasonable cost.
- NMSBA cannot provide cash or equipment to the small business.
- NMSBA cannot provide assistance to government or nonprofit entities.
- NMSBA cannot endorse companies, products, or services.
